Federal Emergency Management Agency Designates Oklahoma Counties as Contiguous Natural Disaster Areas

This Presidential disaster declaration allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through emergency loans. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability.

Impacted Area: Oklahoma

<u>Triggering Disaster:</u> Severe storms, straight-line winds, and tornadoes that occurred May 24, 2024 through May 27, 2024

Application Deadline: January 27, 2025

Primary Counties Eligible: Benton, Boone, Marion

Contiguous Counties Also Eligible:

Arkansas: Baxter, Carroll, Madison, Newton, Searcy, Washington

Missouri: Barry, McDonald, Ozark, Taney

Oklahoma: Adair, Delaware

<u>Disaster 1, Amendment 1:</u> Severe storms, straight-line winds, and tornadoes that occurred May 24, 2024 through May 27, 2024

Application Deadline: February 5, 2025 Primary County Eligible: Baxter Contiguous Counties:

Arkansas: Fulton, Izard, Marion, Searcy, Stone

Missouri: Ozark

<u>Disaster 1, Amendment 2:</u> Severe storms, straight-line winds, and tornadoes that occurred May 24, 2024 through May 27, 2024

Application Deadline: February 12, 2025

Primary Counties: Carroll, Fulton, Greene, Madison, Nevada, Randolph, Sharp

Contiguous Counties:

Arkansas: Baxter, Benton, Boone, Clark, Clay, Columbia, Craighead, Crawford, Franklin, Hempstead, Independence, Izard, Johnson, Lafayette, Lawrence, Newton, Ouchita, Pike, Washington

Missouri: Barry, Dunklin, Howell, Oregon, Ozark, Ripley, Stone, Taney
