# Federal Emergency Management Agency Designates 22 Minnesota Counties as Primary Natural Disaster Areas Due to Recent Severe Storms and Flooding

Numerous additional contiguous counties eligible for assistance due to severe weather in Minnesota and Iowa.

This Presidential disaster declaration allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through <a href="mailto:emergency loans">emergency loans</a>. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability.
