USDA Invests Approximately \$11.5 Million in Composting and Food Waste Reduction Projects in 23 States, Including Wisconsin

MADISON, January 29, 2024 – The U.S. Department of Agriculture (USDA) is investing approximately \$11.5 million in 38 cooperative agreements that support innovative, scalable waste management plans to reduce and divert food waste from landfills. This includes three projects in Wisconsin.

The <u>Composting and Food Waste Reduction</u> cooperative agreements, which are funded by the American Rescue Plan Act, are part of USDA's broad support for urban agriculture. The program is jointly administered by USDA's Office of Urban Agriculture and Innovative Production and the National Institute of Food and Agriculture (NIFA). The recommended projects will be implemented between now and 2026.

"These Composting and Food Waste Reduction projects help communities reduce food waste and greenhouse gas emissions," said Josh Odekirk, Acting State Conservationist of USDA's Natural Resources Conservation Service (NRCS), which houses the Office of Urban Agriculture and Innovative Production.

Added Gene Schriefer, State Executive Director for Farm Service Agency: "Local strategies and tools like these are important climate solutions and also contribute to food security at the community level here in Wisconsin"

USDA prioritized projects that anticipate or demonstrate economic benefits, incorporate plans to make compost easily accessible to farmers, including community gardeners, integrate other food waste

strategies, including food recovery efforts and collaborate with multiple partners. The collaboration between NIFA and the Office of Urban Agriculture and Innovative Production is part of <u>USDA's</u> <u>framework</u> to transform the U.S. food system to benefit consumers, producers and rural communities by providing more options, increasing access, and creating new and better markets for small and mid-size producers.

Recipients include projects in 23 states. Projects in state include: Milwaukee Board of School Directors, the City of Milwaukee, and Dane County.

The Office of Urban Agriculture and Innovative Production was established through the 2018 Farm Bill. It is led by NRCS and works in partnership with numerous USDA agencies that support urban agriculture and innovative production. These cooperative agreements are part of a broader USDA investment in urban and innovative agriculture.?Other efforts include:

- Renewing the <u>People's Garden Initiative</u>, which celebrates collaborative gardens across the

 supporting resilient, local food systems using sustainable practices and providing greenspace.
- Creating and managing a <u>Federal Advisory Committee for Urban Agriculture and Innovative</u>
 <u>Production</u> to advise the Secretary on the development of policies and outreach relating to urban agriculture.
- Investing in <u>risk management education</u> to broaden reach of crop insurance among urban producers.

 Organizing 17?USDA Farm Service Agency (FSA) urban county committees to make important decisions about how FSA farm programs are administered locally. Urban farmers who participate in USDA programs in the areas selected are encouraged to participate by nominating and voting for county committee members.

NIFA invests in and advances agricultural research, education and Extension across the nation to make transformative discoveries that solve societal challenges. NIFA supports initiatives that ensure the long-term viability of agriculture and applies an integrated approach to ensure that groundbreaking discoveries in agriculture-related sciences and technologies reach the people who can put them into practice.
